Fair Use Guidelines, Permissions, and Fees

General guidelines on reproductions

For materials published before 1924, or other materials in the public domain:

We can provide photocopies or scans of original manuscripts, first and early editions of Beethoven's music, 19th-century art engravings, books, articles, and other public domain materials in our collection.

Generally, the Beethoven Center does not copy entire books but can supply photocopies of chapters or other selected pages. Photocopying or scanning of entire books will be decided on a case-by-case basis depending on condition of the original, availability on the antiquarian market, and/or availability in a digital format elsewhere.

For materials published after 1924 or any materials still under copyright

The Beethoven Center can provide photocopies or scans of materials of certain print materials under copyright following the guidelines for fair use. However, we cannot reproduce sound recordings, videos, or other media.

The Fair-Use Statute

(Section 107 of the Copyright Act of 1976. Limitations on exclusive rights: Fair use)

Notwithstanding the provisions of sections 106 and 106A, the fair use of a copyrighted work, including such use by reproduction in copies or phonorecords or by any other means specified in that section, for purposes such as criticism, comment, news reporting, teaching (including multiple copies for classroom use), scholarship, or research, is not an infringement of copyright.

In determining whether the use made of a work in any particular case is a fair use, the factors to be considered shall include:

1. The purpose and character of the use, including whether such use is of a commercial nature or is for nonprofit educational purposes;
2. The nature of the copyrighted work;
3. The amount and substantiality of the portion used in relation to the copyrighted work as a whole; and
4. The effect of the use upon the potential market for the value of the copyrighted work.

The fact that a work is unpublished shall not itself bar a finding of fair use if such finding is made upon consideration of all the above factors (Emphasis added).

The Beethoven Center reserves the right to refuse to accept a copying order if, in its judgment, fulfillment of the order would involve violation of copyright law. All copies become the property of the requestor.

Placing reproduction requests

If the requested materials are available in the Digital Collections, they may be viewed and downloaded without charge. Higher resolution images, or materials not available through the Digital Collections, may be requested on the photoduplication request form.

Please complete the [photoduplication request form](#) and return it by fax or email. If you located the requested material through the online catalog, please provide the shelf number or the permalink of the catalog record and forward these with a note detailing your request. Please include your name, address, phone number, and email address in your request. You will then receive a response giving you the exact amount of your order and an estimated date of delivery. Please allow at least one week for delivery, or more if the request is substantial. You will receive an invoice with your photocopy order, which may be paid by check or credit card. All payments by check must be in US\$. For large orders, payment in advance might be requested.

Scans may also be requested through the Beethoven Gateway Sponsorship Program. These materials will be scanned and made available online through the Digital Collections. Sponsorships of art materials are available for \$30 per item. Sponsorships of manuscripts and rare editions are available for \$10 per page. For more information, see our brochure [pdf]. Permissions

Public domain materials

Many of the Center's art collections (engravings, lithographs, sculpture, etc.), manuscripts, and rare editions have been digitized and are available for viewing and downloading through the Digital Collections. Although materials in public domain may be used without permission, we request that the following ownership credit be added to any document/website/media reproducing the materials: *From the collections of the Ira F. Brilliant Center for Beethoven Studies, San José State University*. Higher resolution images suitable for publication and media presentations may be requested for a fee.

Copyrighted Material

Some materials included in the Digital Collections may be under copyright and are provided for research or teaching purposes under the guidelines for fair use. Higher resolution images of these materials may be requested for a fee. However, providing these images is not an authorization to

publish. If the user wishes to quote, publish, perform, reproduce, or otherwise make any use of the material that requires permission for the copyright holder(s), it is the user's responsibility to obtain all such permissions.

Fees for publications (print and online)

Researchers, students, educational institutions, and non-profits [501(c)3] in the United States may use the Beethoven Center's images in media and publications without additional fees. However, for materials still under copyright, it is the responsibility of those individuals/institutions to obtain permission from the copyright holder.

All publications must include the following credit statement for each image reproduced from the Center's collection:

Reproduced with permission of the Ira F. Brilliant Center for Beethoven Studies, San José State University.

For-profit publishers must pay fees for permission to publish the images provided from the Beethoven Center's collection. Permission is granted for one time, one edition, one publication, one broadcast, one digital press run, or one website use only. Further use requires separate application.

All publishers (non-profit and commercial) will be required to sign a permissions statement provided by the Beethoven Center and returned to the Center for our records.
