Professional Clinical Counselor (PCC) Preparation Information

For students who began the Master's degree program AFTER 8/1/2012

The SJSU Counselor Education Department (EDCO) has been approved by the California Board of Behavioral Sciences (BBS) to offer coursework that meets educational requirements for professional clinical counselor licensure in California.

TERMINOLOGY

- LPCC (Licensed Professional Clinical Counselor) a CA state licensure program administrated by the California Board of Behavioral Sciences (BBS)
- APCC (Associate Professional Clinical Counselor) obtained after completion of an approved 60 semester unit master's degree program and submission of an application to the BBS to commence the required post-master's degree 3,000 clinical internship hours
- Practicum or Field Study Supervised counseling (fieldwork EDCO 292) completed within the master's degree program and <u>before</u> the master's degree is conferred; includes 280 face-to-face clinical counseling hours with individuals, families, or groups
- Internship Supervised counseling (3,000 hours) completed after a candidate's master's degree is conferred
- **Direct Client Hours** Hours spent face-to-face with clients
- Indirect Hours Hours spent not with clients case management, supervision, completing notes, planning for sessions, communicating with other professionals about clinical work

HOW IS BEING LICENSED BENEFICIAL?

- Broader scope of practice integrating socioemotional, academic, and career
- Can practice in a variety of settings including schools, mental health agencies, VA facilities, jails, private practice, hospitals, and many more; not *where* you practice but *how* you practice
- Eligible for jobs comparable to LMFTs and LCSWs
- Potential reimbursement by Medi-Cal and insurance
- Lends credibility to you as a mental health professional
- Competitive for jobs in medical and nonprofit sectors (provides job stability amidst budget concerns)
- Transferable between states (may need to take additional steps, but being licensed in one state often expedites licensure in other states)

STEPS TO BECOME AN APCC

- 1. Complete 60-unit MA + PCC Master's degree program
- 2. Apply to the BBS become an APCC
- 3. Complete post-master's degree internship hours (3,000)
- 4. Pass 2 Exams

APPLYING TO BECOME AN APCC

If you completed a minimum of 60 units and at least 10 of the 13 Core Content Areas for the PCC within your EDCO master's degree, you may be eligible to apply for your APCC number.

• Note that as of 2017, law and ethics (EDCO 232), diagnosis (EDCO 282), and assessment (EDCO 283) must have been completed within the EDCO master's degree program and cannot be remediated. - Professional Clinical Counselor In-State Degree Program Certification Form B Only complete the top section of each page (can be downloaded from the BBS website under the Forms tab: https://bbs.ca.gov/applicants/lpcc.html)
 - The department verifies your SJSU classes and any formally transferred units, if any.

EXAMS

- California Law and Ethics Exam Taken during the first year of having your APCC number
- National Clinical Mental Health Counselor Examination (NCMHCE) Taken after all 3,000 post-master's degree hours are completed
 - *You must pass the California Law and Ethics exam before you can take the NCMHCE.
 - *You may purchase books and study materials to help you prepare for the exams. For example, AATBS has books and provides practice exams.

INTERNSHIP REQUIREMENTS (for 3,000 post-master's degree hours)

Your internship placement, experience, and supervision are not related to the EDCO program. You should follow the BBS guidelines to fulfill their internship requirements, which may include:

- You must have an APCC number to begin your internship.
- Total Required Internship Experience = 3,000 hours including

FREQUENTLY ASKED QUESTIONS

Q: What if I am missing courses required for PCC preparation?

A: As long as you have met the minimum core content areas required within the degree, you can remediate the missing course(s) through a BBS-approved provider: http://calpcc.org/graduate-course-providers

Q: Can I get all of my courses signed off by EDCO even though I am missing a core content course or am currently taking it outside of EDCO?

A: No. We need to verify that all coursework has been completed before we (EDCO) can sign off on it. Note that we can only verify coursework taken within the EDCO graduate program and units formally transferred to SJSU.

Q: I already graduated from EDCO. Can I still apply for the APCC?

A: Yes. To be eligible for the LPCC, you <u>must</u> have completed the minimum requirements within your degree: (a) 10 of the 13 core content areas; (b) 6 units of 292; (c) 15 units of advanced coursework; (d) MA degree must contain at least 60 units. Note that as of 2017, law and ethics (EDCO 232), diagnosis (EDCO 282), and assessment (EDCO 283) must have been completed within the EDCO master's degree program and cannot be remediated.

Q: What if I did not complete the LPCC minimum requirements before I graduated?

A: Unfortunately, your degree would NOT be eligible for LPCC licensure.
