**Course Description (Required)**

**Treatment of essentials of U.S. and California government. Satisfies the American Institutions requirements in U.S. Constitution (US2) and California Government (US3), and the Core GE requirement in Social Sciences: Social Issues (D3). GE Area: D3, and American Institution Requirement: US2 and US3**

**Course and GE Learning Objectives (CLOs and GELOs):**

Upon successful completion of this GE course, students will be able to:

## MindTap Assignments

You will complete MindTap Assignments each week. These are available in your Canvas course must be completed prior to the deadline. In each unit, you'll complete two assignments: a "Learn It" assignment and an "Apply It" quiz. They are marked "Counts Toward Grade" in MindTap. Activities that are not marked "Counts Toward Grade" are for practice only, and they do not count toward your grade.

## Exams

There will be two midterm exams and a final exam. All exams are open notes and open book. You will take these exams online. Your two highest exam scores will be used to calculate your grade (one exam score is dropped). There are no makeup exams for any reason whatsoever. You must take the final exam.

## Active Learning Project

You will upload a presentation to the class on an active learning project you have undertaken over the course of the semester. You have from today until the presentations to engage in a local political activity. **Note: None of these political activities must be done in person! Please look for virtual options!** Ideas for local activities you can participate in for active learning:

- Virtually attend a city council meeting
- Virtually attend a school board meeting
- Virtually attend local Democrat or Republican party meeting or event
- Watch the Democratic or Republican National Convention
- Track a piece of legislation in the state legislature (check their website for info. Note, you do not need to drive to Sacramento to track legislation!)
- Register to vote
- Contact the mayor or your Congressperson to tell them your opinion on a political issue
- Watch a current court case

Please note: this isn't a research paper! The goal is for you to DO something CURRENT and POLITICAL.

If you have an idea that is not listed above, please email me for approval. You will create a power point presentation that is 5-10 slides that outlines your experience. In your presentation you will 1) describe your active learning project activity, 2) explain how it relates to the concepts we have learned in class so far, 3) offer your insight into how it made you a more engaged political citizen. Note: the power point should be succinct! You should never have more than 50 words on a single slide. Give me the highlights. You must ALSO submit a 400-500 word essay outlining those same three things. You will upload your assignments in Canvas by the deadline.

## Mini-Lecture Reflection

About once a week, I will post a mini-lecture as an announcement related to something in political science or topical in American Government. Twice during the semester, you'll write a 150-200 word reflection on ANY of the lectures that have been posted.

## **Final Paper**

Your final paper must be at least 900 words (about 4 pages double spaced). You will find a current event in the U.S. politics and write a paper that connects that event to the concepts you have learned in this course. More information about the specifics of the paper will be provided in Canvas.

## **Grade Distribution**

The grading breakdown for the course assignments is as follows:

- Average for MindTap Assignments – 18% total
- Mini Lecture Reflections – 6% each (12% total)
- Active Learning Project Essay – 15%
- Active Learning Project Presentation – 10%
- Final Paper – 15%
